1. Notified Mr. Shannon Shaw of Bureau of Land Management 24 hrs. prior to commencement of casing integrity test.
2. Installed chart recorder on casing.
3. Rigged up kill truck and loaded backside with 2% KCl w/corrosion inhibitor.
4. Pressured up on casing/tubing annulus to +500 psig for +15 minutes.
5. Rigged down kill truck and chart recorder.
