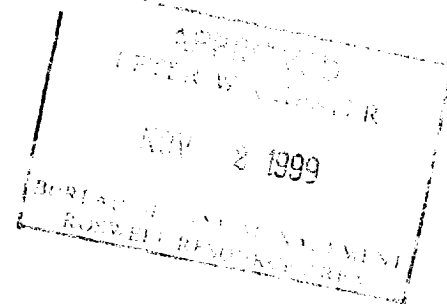

Marathon Oil Company plans to change the configuration of the piping of the gas production from this well. The gas will flow from the wellhead to a separator, located at the well site, where it will be measured and then transported to a compressor and dehydration unit, also located at the well site. After being processed through the dehydration unit, the gas will be sent to the fuel gas header and then on to one of the satellite facilities' fuel gas system. The gas not needed for the fuel gas system will be transported via pipeline to Marathon's Indian Basin Gas Plant where it will be processed and sold at the tailgate of the plant. Please see the attached flow diagram of the proposed piping configuration.
