Cemented w/ 425 sx. 50-50 Pozmix w/ .3 of 1% CFR-2 and 8# salt per sx. Plug down @ 5:00 P.M., 12-1-77. Pressure tested casing @ 1500# for 30 min., held O.K. WOC for 18 hours. Ran temperature survey w/ top of cement @ 3020'.
