Marathon Oil Company initiated operations to recomple the above referenced well to the Wolfcamp formation on July 10, 1989. Following is the procedure:

1. MIRU pulling unit, reverse unit & H₂S equipment.
2. Killed well w/2% KCl water.
3. ND tree. NU 6" 900 series BOP.
4. Released pkr & POOH w/pkr & 2 3/8" prod. string.
5. RU wireline contractors. Ran GR-CCL from 6400'-6100' & 7200'-7100'.
6. Set CIBP @ 7170'. Dump bailed 6 sx. cmt. on top of CIBP.
7. Loaded hole w/2% KCl water & tested to 1000 psig. Held OK. Est PBTB @ 7118'.
8. Ran GR-CBL-CCL from 6500'-4500' w/1000 psig pressure. Good bond from 6500'-6170'. RD wireline contractors.
