

Marathon Oil Co. is requesting renewal of the Temporary Abandonment status of this well. TA status was originally approved 9/23/93. The casing integrity was tested on 11-16-98. If no commercial production can be found the well may have utility as a water disposal well. As development continues in the Indian Basin and Dagger Draw areas, additional disposal capacity may be required. In the meantime the well has value as a reservoir observation well.
