TD 403' Lime. Spudded @ 7 A.M. on 11-15-67. Ran 10 joints (379.40') 13 3/8" OD 48# J-55 casing. Set at 400'. Cemented with 285 sax Class C w/12 1/2# sack gilsonite and 2% CaCL2. Followed by 50 sax neat Class C. Plug down at 7:45 P.M. 11-17-67. Cement did not circulate. Filled annulus between 13 3/8" and 17 1/2" hole w/150 sax Class C with 12 1/2# sack gilsonite and 2% CaCL2. Tested 13 3/8" casing w/600 psi for 30 minutes with no drop in pressure. Prep. to drill ahead.
