Drilled 7-7/8" hole to 7610' TD. Two DST's in Wolfcamp and three DST's in Cisco and logs proved the well to be non-commercial. We propose to plug and abandon by setting the following common cement plugs:

- 30 sx 7510-7610 (Cisco Canyon)
- 30 sx 7200-7300 (Cisco Canyon)
- 30 sx 6400-6500 (Wolfcamp)
- 60 sx 4860-5060 (Wolfcamp)
- 30 sx 3250-3350 (Bone Springs)
- 30 sx 1750-1850 (Across 8-5/8" casing shoe)
- 10 sx 10- 50 In top of well.

9.0# mud will be left between all cement plugs. Both 13-3/8" and 8-5/8" casing strings will be left intact.
