Marathon Oil Company initiated operations to plug and abandon the above referenced well on 2-2-90. Following is the procedure:

1. MIRU pulling unit.
2. ND tree. NU BOPs.
3. Set CIBP @ 2300'. RIH w/tbg to 2300', circ hole w/10 ppg mud & spot five (5) sacks cement on top of CIBP. Pull tbg to 1160' & spot ten (10) sack cement plug. POOH w/tbg. WOC 2 hrs. RIH w/bullplugged perforated sub on 2 7/8" tbg to 1160'. Did not tag plug. Circ cement out of hole. Mix & pump 90 sacks cement. Circ to surface. (Above change of procedure approved on location by B.L.M. representative Daniel Cortez.) POOH w/tbg.
4. Cut off wellhead. Weld on dry hole marker. Well P&A'd 2-3-90.
5. Location ready for inspection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
