T.D. 750' Line. Prep to drill ahead. Spudded w/ Rathole Machine on 6-20-73. Ran 1 ft. of 30" conductor pipe set @ 25' w/ 3 yds., Redmix cement. Spudded w/ rotary on 6-25-73. Drilled to a T.D. of 750' Line. Ran 25 jts. (735.10') 16" OD 65# E-40 csg., set and cemented @ 750' w/ 500 sx Howco Lite w/ 2% CaCl, 5% Gilsomite and 1/4# Flocele/Block followed by 350 sx Class C w/ 2% CaCl cement. Plug down @ 9:55 A.M., on 6-28-73. Had full returns during cementing process but cement did not circulate. WOC 6 hrs. Ran temp survey. Top of cement @ 80'. Ran 1" tubing in annulus to 77' and cemented w/ 200 sx Class C w/ 2% CaCl cement. Circulated 20 sx to pit. WOC 13 hrs. Total WOC time of 20 hrs. Tested 16" csg and BOP to 700 psi for 30 minutes w/ no drop in pressure. NOTE:

USGS was notified but did not witness cementing.

CONDITIONS OF APPROVAL, IF ANY:

Instructions
