The above (2) two wells are producing permit water from the Delaware Bones springs and Delaware upper sandstone respectively and at a rate of 20 bbls/day and 10 bbls/day respectively. The produced water is pumped to location from each well and stored in a 210 bbl open top fiberglass tank (with fuel nozzles) and from there it is pumped to our Government "D" Saltwater Disposal system where it is then pumped into our disposal wells Government D-1 & Government "D" 4 SWD. Refer to Case Serial # NM-94378 for track of disposal lines to our system. 3.5 miles. NMOCB Permit #15 ARE D-1 SWD-579 & D-4 SWDR-8294. See attached Water Analysis per wells.
