This well has recomple potential. Marathon is currently reviewing our leases in Eddy & Lea County, New Mexico for recomple and deepening potential. This work is expected to be completed in the latter part of 2001.

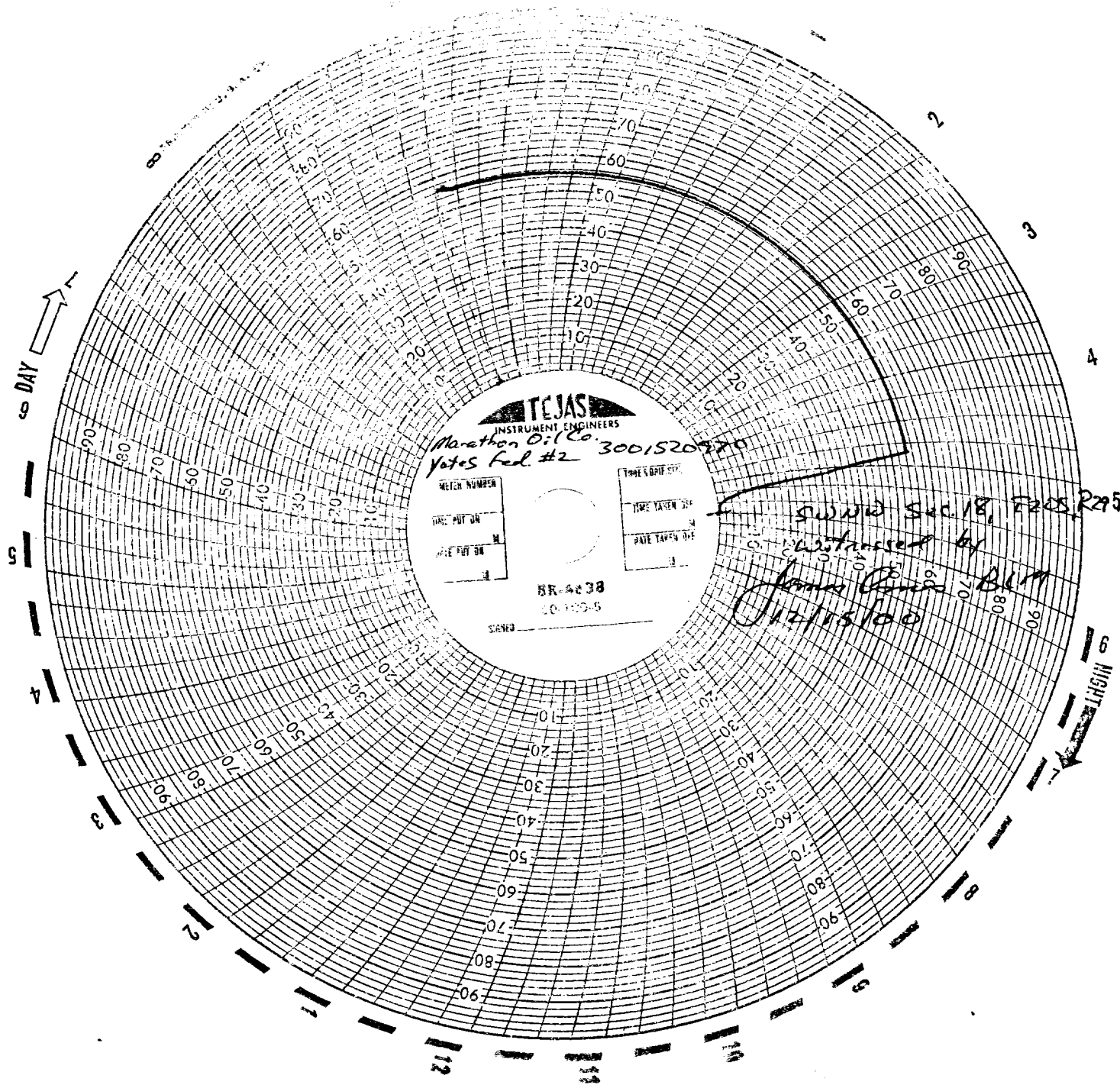
