Drilled 12 1/4" hole to 1842'. Ran 50 joints of 9 5/8" 36# K-55 casing set at 1842'. Cemented with 800 sacks Lite-Wate + 2% CaCl and 250 sacks Class "C" + 2% NA-5. Plug down 9PM 3-22-74. Cement did not circulate, top of cement outside casing at 640' by temperature survey. Cemented annulus through 3/4" tubing in three stages as follows:

Stage 1: Tagged cement at 590', cemented with 50 sacks Class "C" + 4% CaCl.

Stage 2: Tagged cement at 500', cemented with 50 sacks Class "C" + 4% CaCl.

Stage 3: Tagged cement at 180', cemented with 150 sacks Class "C". Cement circulated at 4:50PM 3-23-74. Tested casing to 1000 psi for 30 minutes, held OK.
Drilled plug, cement and shoe, tested to 150 psi for 30 minutes, held OK.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
