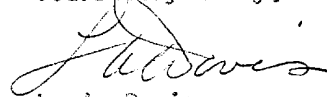
Mobil Oil Corporation respectfully requests administrative approval of a non-standard gas proration unit for the subject well. This well is located in Lot 7, Unit G, 1500 ft from the north line and 2100 ft from the east line of Sec. 6, T-21-S, R-27-E, Eddy County, New Mexico. This proposed non-standard unit is necessitated by a variation in a legal subdivision of the U.S. Public Surveys. It will comprise Lots 1, 2, 3, 4, 5, 6, 7 & 8 of said Sec. 6, and it will contain 275.32 acres of land more or less.

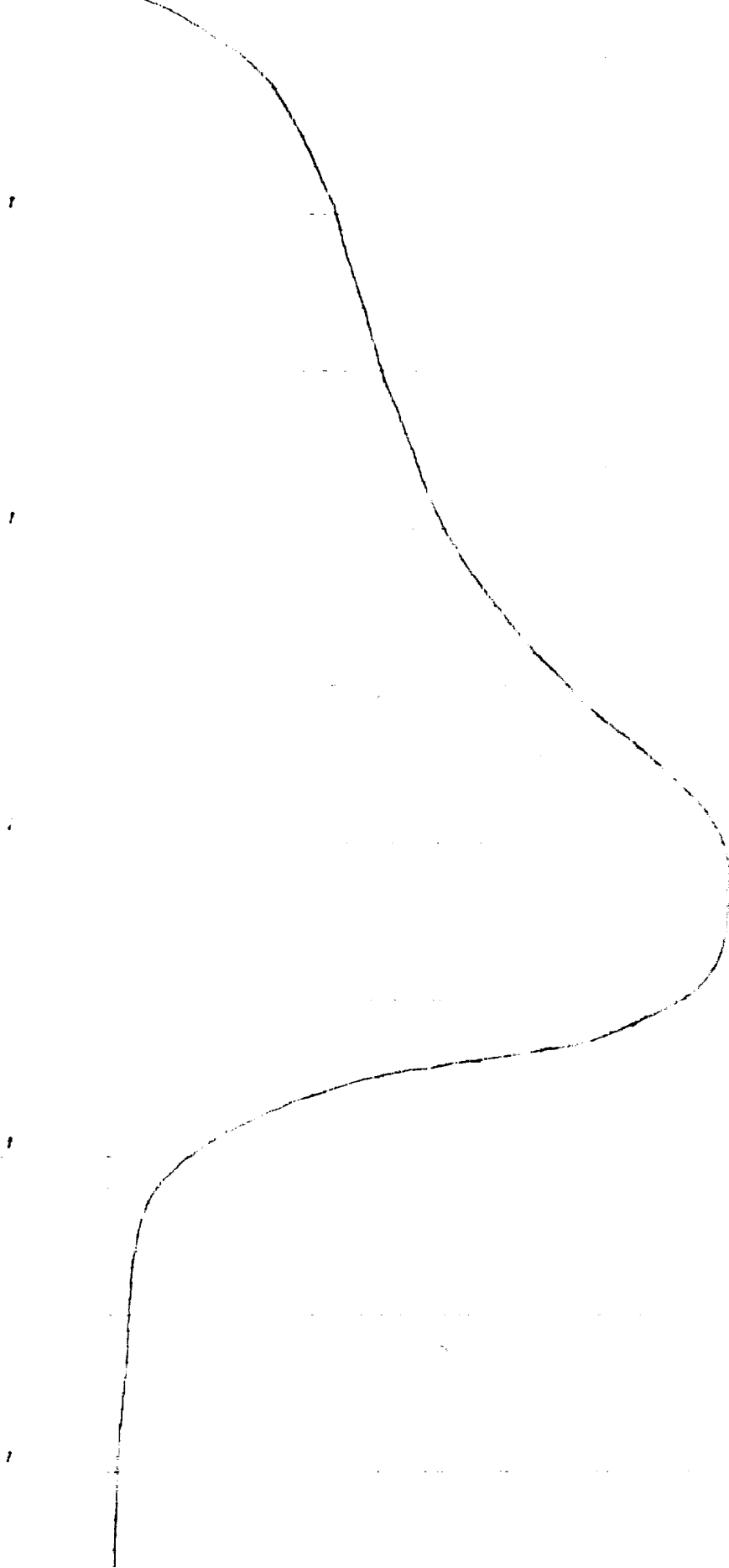

THE REASON FOR THIS INTERPRETATION IS THE DIFFERENT GRADIENTS BETWEEN THE DEPTHS OF 485' AND 765'. THIS CEMENT WAS OVER 24 HOURS OLD AND WITH THE 4% GEL ADDITIVE IT WILL NOT GET AS HOT, OR RETAIN ITS HEAT AS NEET CEMENT WILL DO.

THE ZONE THAT IS SHOWING HOT IN THE AREA OF 300' TO 400' IS A KNOWN LOST CIRCULATION ZONE WITH A LARGE VOLUME OF CEMENT IN THIS AREA. SAME IS TRUE FOR THE AREA BETWEEN 1500' AND 1650'.
