Spudded 11:00 AM 30 April, 1974. Drilled 17-1/4" hole to 360'. Cemented 13-3/8" 54# J-55 casing @ 360' with 200 qt. Halocelish containing 1/4#/sx Flocele, 5#/sx gilsonite, and 21 CaCl₂ followed by 100 sx. Class "C" cement containing 22 CaCl₂. Cement circulated. Plug down 10:00 AM 2 May, 1974. WOC 18 hrs. Tested casing with 1000 psi for 30 mins. No decline in pressure. Drilling ahead with 12-1/4" bit.
