20-29-74 Drld 12 1/4" hole to 3124' and ran 8 5/8" 24# & 32# K-55 csg. Set at 3124' and cmt'd w/1900 sx. Cmt did not circulate. Temperature survey showed top of cmt at 1800'

10-30-74 Cmt'd back to surface w/1" pipe in 3 stages w/750 sx.

12-27-74 Drilled 7 7/8" hole to TD of 12,000'

12-30-74 Ran 4 1/2" 11.6# & 13.5# N-80 csg. Set at 11,258' and cmt'd in 2 stages. Cmt'd 1st stage w/650 sx w/stage tool and 2nd stage w/800 sx.

1-11-75 Perf'd 11,002-006 w/4 JSPF. Did not acidize perfs.

1-24-75 Perf'd 9402-06, 9416-20, 9428-32, 9442-46, 9454-58, 9468-70 w/2 JSPF. Did not acidize perfs.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
