Under the provisions of Case No. 6109, Order No. R-5615 dated January 4, 1978, the Burton Flat-Morrow and the North Burton Flats - Wolfcamp pays are now commingled and future production will be thru a common tubing with a packer at 8817' and the tubing open to Wolfcamp and Morrow at 11145'. It is proposed to allocate future production (justification and calculations attached) as follows:

Burton Flat - Morrow Gas - 86%, Condensate - 49%
N. Burton Flat - Wolfcamp Gas 14%, Condensate - 51%
