- Set retainer at 9800'. Run tubing string into retainer and squeezed with 50 sacks of cement at 2800' OSE. Unstring from retainer and dumped 5 sacks on top of retainer. Work performed on 8-13-79.
- Cut 4 1/2 casing at 7181' and pulled out hole with casing.
- Run tubing and spotted a 65 sacks at 7281' waited on cement and taged plug at 7011'.
- Pulled tubing to 4761 and spotted a 35 sacks.
- Pulled tubing to 2751' and pumped a 50 sack plug waited on cement and taged plug at 2625 feet.
- Pulled tubing to 450 ft. and spotted a 35 sack plug.
- Pulled out hole cut off well head. Placed 10 sack surface plug. Installed dry hole marker and rigged down. 8-17-79.
