Spudded at 8:00 am 7/29/76. Drilled 17 1/2" hole to 400' at 9:30 pm, 7/29/76. Ran 10 joints 420.49', 13 3/8", 48# H-40 ST&C casing, set at 400'. Ran Halliburton guide shoe, insert float and two S-3 centralizers. Cemented with 400 sx Class "C", with 2% calcium chloride. Plug down at 2:30 am, 7/30/76. Cement circulated. Pressure tested to 650# for 30 minutes, no measurable drop in pressure. WOC to set 19 hours, prior to pressure test.
