Plan to test additional Morrow perforations 11507-13'. If commercial, will stop and produce. If not commercial, will set RBP (test RBP) above Atoka/Morrow and test Strawn 10389-10572'. If Strawn is commercial, will produce until pressure drops. Will then apply to downhole commingle the Strawn and Atoka-Morrow to maximize hydrocarbon recovery and prevent mineral waste. If Strawn is non-commercial will evaluate additional recompletion potential and/or apply to commingle Strawn and Atoka-Morrow.
