13 Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Propose to plug and abandon as follows:

1. TIH with tubing and tag cement retainer @ 6480'. Load the hole with plugging mud. Spot a 5 sack Class C cement plug on top of the retainer from 6,440' to 6,480'. POOH.
2. TIH with WL to set CIBP @ 5918'. TIH with tubing, load with plugging mud and spot a 5 sack Class C cement on top of the CIBP. Spot a 20 sack plug from 1400' to 1597'. POOH.
3. RU WL and cut 5.5' casing @ 1,100'. TOH with WL and attempt to pull casing.
4. TIH with tubing load hole with plugging mud and spot 50 sacks Class C cement plug from 960' to 1150' across the 5.5" casing stub. WOC.
