Propose to re-stimulate existing perforations as follows:

1. Nipple down tree and nipple up BOP. TOOH with tubing and packer.
2. TIH with tubing, packer and RBP with ballcatcher. Set RBP at 5900'±. Pickle tubing and reverse acid out with treated water. Latch onto RBP and move to 7725'± and set packer at 7508'±.
3. Acidize perforations 7538-7695' (Strawn) as necessary for production.
4. Swab/flow test for cleanup.
5. Unset packer and RBP. Move RBP to 6440'± and packer to 5990'±.
6. Acidize perforations 6020-6410' (Cisco) as necessary for production.
7. Swab/flow test for cleanup.
8. POOH with tubing and tools. Place well into production.

NOTE: If decision is made to commingle Cisco and Strawn perforations, application will be made to BLM and OCD.
