Bass Enterprises requests TA status extension until 7/27/03 while we evaluate the wellbore for other production potential or for possible use as a salt water disposal well. New technologies are continually being developed that may allow us to return the well to production. Also, new plays are constantly being developed in Southeast New Mexico whose profitability may hinge on readily accessible and cheap salt water disposal capacity. It is for these reasons that TA status is requested. As always, Bass will strive to be a prudent operator by performing annual MIT tests so as to ensure the mechanical integrity of the wellbore.
