Mixed and spotted 35 sacks Class C cement from 1353-1252'. POOH with tubing. Shut down for night. 2-8-95 - TIH with tubing and tagged top of cement at 1245'. Spotted 75 bbls plug mud from 1245' to surface. POOH with tubing to 310'. Mixed and pumped 30 sacks Class C cement from 310-210'. POOH with tubing to 50'. Spotted 15 sacks Class C cement from 50' to surface. POOH and laid down tubing. Nippled down BOP. Installed regulation abandonment marker. **PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed 2-7-95.**
