Ran 49 joints 8-5/8" 24# K55 casing, set at 2000', cemented with 200 sx. false set, 1/4# cello flake, 5# Gilsonite, 500 sx. of 2% Lodense with 1/4# cello flake, 5# Gilsonite, 8# salt, 150 sx. Class "C", 2% KCL. Ran 1" hit top of cement at 330' cemented 25 sx. filled up 30' cemented 35 sx., filled up 10', cementing. 25 sx. cement, no fill; dumped 1 1/2 yds. pea gravel; cemented with 25 sx. cement, no fill; 1 1/2 yds. pea gravel; cemented 25 sx. top of cement 270'; cemented with 5 yds. Ready mix concrete; then cemented to surface with 90 sx. of cement. WOC 12 hrs. Press. tested 8-5/8" casing to 1000# for 30"-held OK.
