Gentlemen:

By letter of August 21, 1979, we submitted two copies of an Application for Well Status Determination for each separate category (i.e. Sections 102 (c) (1) (C) and 103) pursuant to the Natural Gas Policy Act of 1978, and the rules presented by the Oil Conservation Division of the Energy and Minerals Department, State of New Mexico.

We requested that multiple determinations be made by the Director for this well. Such multiple determinations to be considered by the Commission are two fold: Section (c) (1) (C) New Onshore Reservoir, and Section 103 New Onshore Production Well, under the Natural Gas Policy Act of 1978. All forms, information and sworn statements were submitted separately under this application.


