Drilled 12-1/4" Hole to 1,600'. Ran and cemented 39 Joints of 8-5/8" 32# J-55 Casing @ 1,600' with 200 sx. Thixset cement containing 10#/sx. Gilsonite, 1/4#/sx. Flocele and 2% CaCl₂, 550 sx. Halliburton Lite cement containing 5#/sx. Gilsonite, 1/4# sx. Flocele & 2% CaCl₂ and 200 sx. Class "C" cement containing 2% CaCl₂. Plug down 11:00 AM July 13, 1979. Circulated 300 sx. WOC 18 hrs. Tested casing w/2000 psi. - 30 mins. - OK. Drilling ahead w/7-7/8" bit.
