T.D. 600' surface rock. Prep to drill ahead. MURU rotary & spudded a 17½" hole @ 1130 MDT on 5/30/80 & drilled to a T.D. of 600' in surface rock. Ran & set 14½ jts (581.30') 13-3/8" OD 8R 48# H-40 casing @ 600' & cemented w/650 sx Class C w/2% CaCl₂ cement. Circulated 210 sx cement to pit. USGS was notified but did not witness cementing job. Bumped plug w/600# - held ok. WOC 8 hrs. NU BOP & tested BOP & casing to 500# - held ok.
