This well was originally drilled to a T.D. of 11,500' and completed in the Wolfcamp on January 27, 1981. The Morrow and Atoka Formations were tested and found to be non-commercial prior to plugging back and completing in the Wolfcamp. After depleting the Wolfcamp, the well was plugged and abandoned in November, 1982. It is proposed to recompleate this well in the Bone Springs Formation in the following manner:

1. MIRU a pulling unit and drill out the surface plug @ -0- - 50' and the downhole plugs @ 401 - 660', 2890 - 2990', 4300 - 4400', 4650 - 4750' and 5550 - 5650' and CO to 6500'
2. RIH w/OE'd tubing to 6500' and spot a 110 sack Class C cement plug @ 6500 - 6200'. POOH and WOC for 24 hrs.
3. RIH w/7-7/8" bit and DC's on 2-7/8" tubing and dress off cement plug from 6200 - 6300'.
4. Run and set 5-1/2" OD 15.5# casing @ 6300' and cement w/450 sacks of Class C

INSTRUCTIONS

GENERAL: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations.
