MIRU a pulling unit and drilled out the surface plug @ 0 - 50' and the downhole plugs @ 401 - 660', 2890 - 2990', 4300 - 4400', 4650 - 4750' and 5550 - 5650' and cleaned out to 6503'. POOH w/tubing and rotary bit. RIH w/OE 2-7/8" tubing and spotted a 110 sack cement plug @ 6503 - 6203'. POOH and WOC for 24 hrs. RIH w/tubing and rotary bit and tagged cement plug @ 6264' and drilled hard cement to 6300'. POOH w/tubing and rotary bit. Ran and set 146-1/2 Jts (6282') 5-1/2" OD 15.5# casing @ 6299' and cemented w/450 sacks of Class C 50/50 Poz Lite 3 w/6# salt, 2% Bentonite & 0.3% D65 TIC/sack cement. PD @ 1230 MDT on 10-23-84. WOC 18 hrs. ND BOP, set slips, cut off casing and NU WH and BOP.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
