1. Rigged up B & E Kill Truck.
2. Loaded Tubing/Casing Annulus with 26 Bbls 2% KCl water.
3. Pressured Tubing/Casing Annulus to 600 psig. Shutdown Kill truck pump and held 600 psig pressure on annulus for 15 minutes. (See attached chart).
4. Released pressure and rigged down kill truck.

NOTE: Test was not witnessed by BLM. Approval to proceed with test was received from Mr. Shannon Shaw by Steve York (Marathon) per telecon on November 30, 1990.

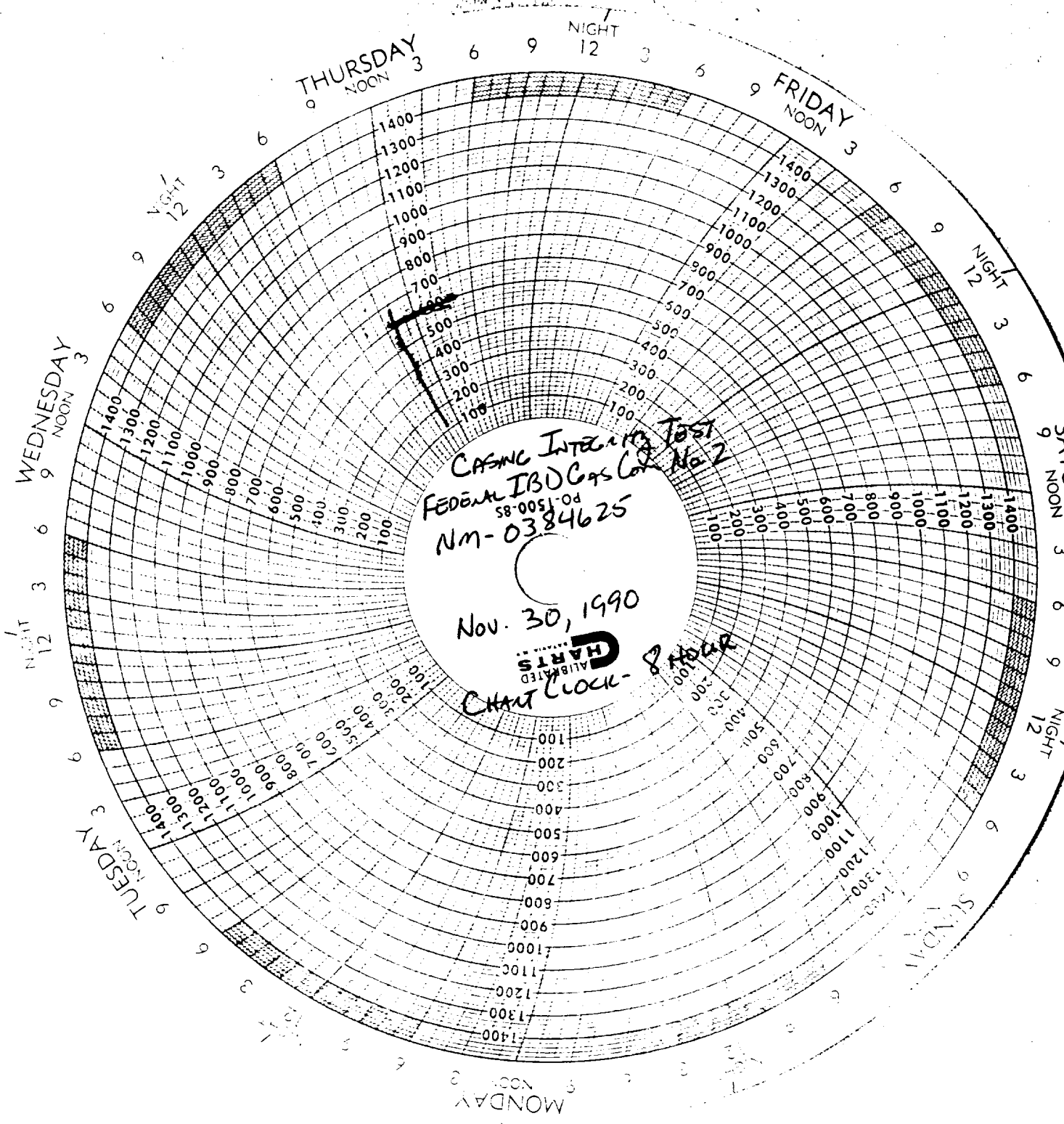
