4. RIH w/Baker Locset packer on 2-7/8" tbg & set packer @ approx 11,850'.
5. Swab & flow test perfs.
6. If warranted, acidize Atoka perfs (11891' to 11896') w/2000 gals acid.
7. Flow back & test.
