APPROVAL IS REQUESTED TO ADD A 50 GAL PRESSURE TANK (125 PSIG MAWP) IN THE VICINITY OF THE WSW #1 TO HOLD WATER. TANK WILL BE ON EXISTING PAD FOR WELL #514. ALSO, ADD 2", BURIED POLYETHYLENE LINE FROM 50 GAL TANK TO WATER INJECTION FACILITY AT THE CENTRAL TANK BATTERY (PLAT IS ATTACHED). 2" LINE WILL BE INSTALLED PER SPECIFICATIONS IN THE AVALON (DELAWARE) UNIT SURFACE USE PLAN. LINE WILL BE LAID ALONG EXISTING RIGHT-OF-WAY SO NO NEW SURFACE DISTURBANCE WILL OCCUR.
