Spudded well with 17 1/2" hole on 4-19-83. Drilled to 590' and ran 16 jts 13 3/8", 48#, H40, ST&C casing set at 590'. Cemented with 100 sx "H" + 10% A-10 + 2% CaCl, 430 sx "C" + 2% CaCl + 1/4# Cello-Flakes, and tailed in with 200 sx "C" + 2% CaCl. PD at 1330 hrs, 600 psi on casing. Cement did not circulate. Tagged TOC at 62' with 1" pipe. Set one plug with 150 sx "C" + 2% CaCl + 1/4# Cello-Flakes to circulate. Reduced hole to 12" and drilled ahead on 4-21-83. WOC total of 19 hours.
