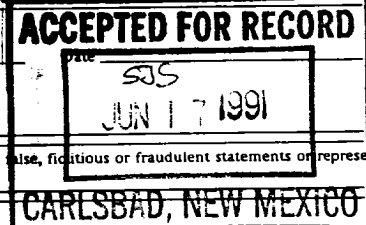

## SPECIFIC INSTRUCTIONS
