This well has recompleat potential. Marathon is currently reviewing our leases in Eddy and Lea County, New Mexico for recompleat and deepening potential. This work is expected to be completed in the latter part of 2001.

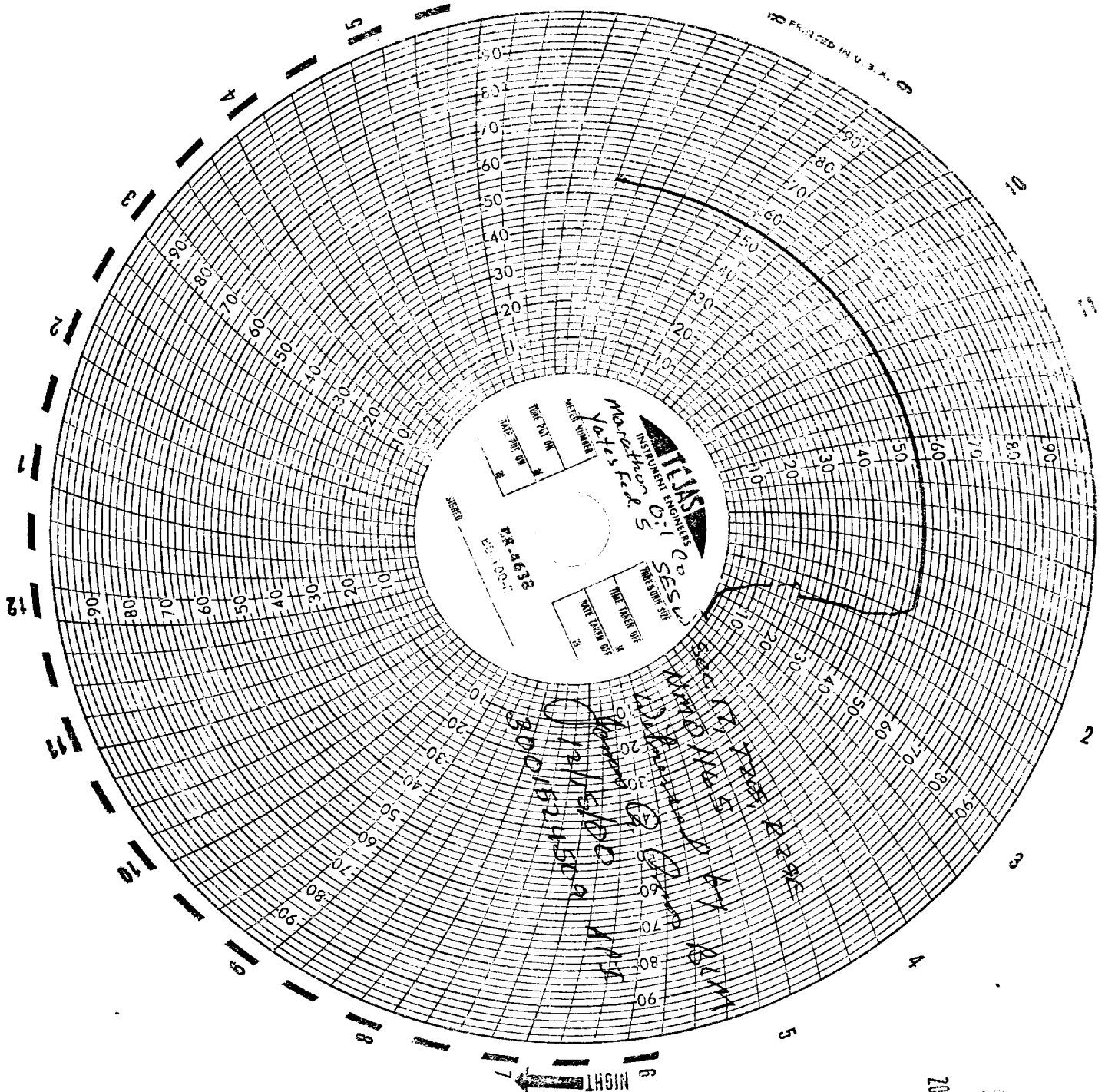
