We respectfully request to temporarily abandon the ADU 236, (Previously known as the Stonewall WM State #2). The well is to be saved for a return to production or some other beneficial use at a later date. A 5-year TA status is requested.

The procedure to be followed is listed below.

Lay rods down and pull tubing out of the well.

Set cast iron bridge plug at about 2550' with 35' of cement atop. T. Perf. 2686'. Set CTBP @ 2586'.

Pressure test casing to 500 PSI for 30 minutes.
