CLEAN OUT WELL TO 3,900'.
PICK UP BULL DOG BALIER AND NEW 2.875 TUBING STRING.
RUN TUBING IN THE HOLE.
NIPPLE DOWN BOP AND NIPPLE UP WELLHEAD
INSTALL PUMP AND PUT WELL ON PRODUCTION.
