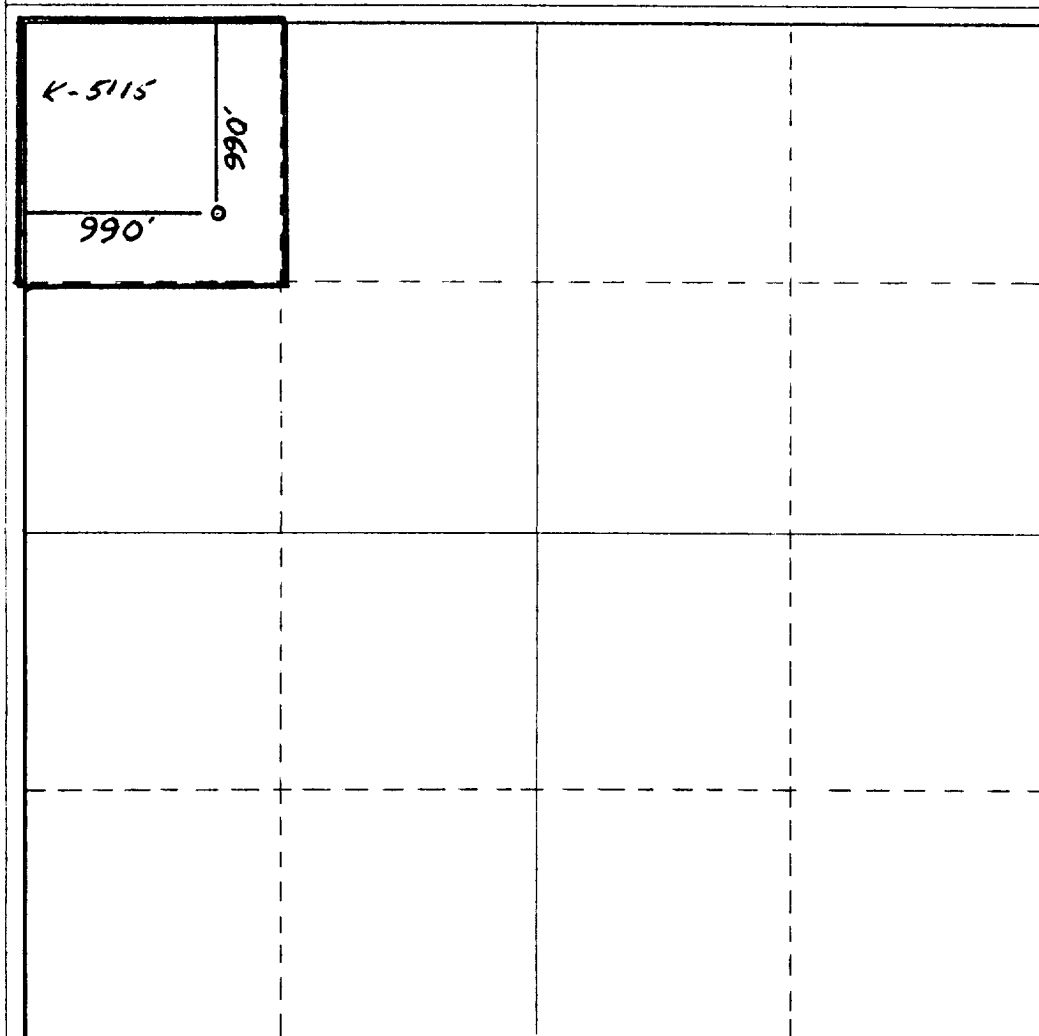

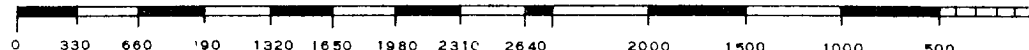


EXHIBIT B
