Marathon Oil Company respectfully requests permission to recomplete the above referenced well to the Strawn formation upon approval of Form 3160-5. Following is the proposed procedure.

1. MIRU pulling unit. Release pkrs and POOH.

2. RU wireline w/full lubricator. Load hole w/2% KCl.

3. Set CIBP @ 11,150' w/50 ft of cement on top. Test CIBP to 500 psig.

4. Run CBL-GR-CCL from 11,100' to 9,800'.

5. Perforate w/3 1/8" csg gun @ 10,575'-10,581', 10,588'-10,594', 10,258'-10,263', 10,266'-10,271', 10,273'-10,277' with 2 JSPF (64 holes).

6. Acidize with 3,600 gals 15% NEFH and 128 RCN balls for diversion.

7. Swab well and place on production.
