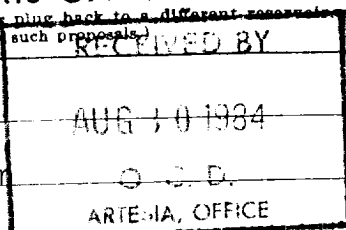

T.D. 2450' Anhydrite. Prep to drill ahead. Drilled a 12-1/4" hole from 400' to a T.D. of 2450' in Anhydrite. Ran and set 56 Jts.(2206.65') 8-5/8" OD 24# and 5 Jts.(222.35') 8-5/8" OD 32# casing @ 2449' and cemented w/850 sacks TLW w/4% gel, 5# gilsonite & 0.25# flocele/sack + 200 sacks of Class C w/2% CaCl₂/sack cement. PD @ 1730 MDT on 8-15-84. No circulation throughout the job. WOC 6 hrs. Ran temp. survey. TOC @ 1290'. Ran 1" tubing in annulus and tagged cement @ 1290'. Mixed and pumped 100 sacks of Class C w/3% CaCl₂. TOH w/1" tubing. WOC 2 hrs. TIH w/1" tubing and tagged 1st plug @ 1240'. Spotted 100 sacks of Class C w/4% CaCl₂ cement. WOC 2 hrs. Tagged 2nd plug @ 930'. Spotted 100 sacks of Class C w/4% CaCl₂ cement. WOC 2 hrs. Tagged 3rd plug @ 660'. Spotted 100 sacks of Class C w/4% CaCl₂ cement. WOC 2 hrs. Tagged 4th plug @ 527'. Broke circulation w/F.W. Mixed and pumped 200 sacks of Class C neat. Circulated 10 sacks to the surface. WOC 18 hrs. Tested the 8-5/8" OD casing to 2300# for 30 min. - OK.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
