3-10-95 - Moved in and rigged up pulling unit.
3-11-13-95 - Rigged up cable spoolers. Nippled up hydril BOP. TOOH with sub pump. Loaded 5-1/2" casing with 2% KCL. Did not load. Shut blind rams. Shut down.
3-14-95 - TIH with packer and 2-7/8" tubing to 10797'. Set packer at 10797'. Tested annulus to 500 psi, OK. Established injection rate of 0 psi at 5 BPM into operations 10876-10084'. Pumped 2000 gallons of 80# crosslink gel with 17 gallon oyster shells at 3 BPM at 50 psi. Flushed 63 bbls to end of packer. Wait 30 minutes and load annulus with 25 bbls 2% KCL. Circulated. TOOH with 2-7/8" tubing and packer. APR 2 1995
3-15-95 - TIH with bit, drill collars and 2-7/8" tubing to cement retainer at 11025'. Rigged up power swivel and drilled out cement retainer and cement to 11100'. TOOH with tubing, drill collars and bit. TIH with bit, scraper and 2-7/8" tubing to 11100'. Circulated casing clean with 2% KCL water. TOOH with tubing, scraper and bit. DROPT 2.
3-16-95 - Rigged up wireline. TIH with 4" casing guns and perforated 10898-10907' and 11066-11076' w/42 .40" holes (2 SPF). TOOH with casing guns and rigged down wireline. TIH with RBP, packer and 2-7/8" tubing. Set RBP at 11110'. Tested to 1000#, OK. Moved up and set packer at 10984'. Acidized perforations 11066-11076' with 4000 gallons 15% NEFE acid and 30 ball sealers. Unset packer at 10984'. Dropped down and unset RBP at 11110'. Moved up and set RBP at 10953'. Tested RBP to 1000 psi, OK. Moved up and set packer at 10797'.
