1. Pull both strings of tubing and bath packers.
2. Set CIBP at 8215' and cap with 35' cement.
3. Re-perforate the Cisco at 7438-46' and 7460-78' and acidize.
4. Run submersible pump to pump test the Cisco perfs 7434'-7478' to evaluate commerciality.

Anticipated start date is July 15, 1993, pending BLM and OCD approval.
