Continue to drill plugs at 4958'; 7150'; 8756'; 9518';

Tagged plug at 11,247', did not drill out.

Ran 250 joints of 5.50" 17#/ft., P-110, N-80 and Buttriss LT&C casing set at 11,200' K.B. On October 21, 1992.

Cemented with 1275 sacks Premium Plus cement, 8% Halad 413; 4# Micro-Bond M; and 3% HR-5 (1.17 cu.ft./sk. yield, 16.0#/gallon). Plug down at 5:29 PM October 21, 1992.

As of October 21, 1992: Well Status waiting on completion.
