1. Set CIBP @ 8100'+ and cap with 50' of cement.
2. Displace hole with 10# brine plug mud.
3. Spot 200' Class "H" cement plug @ 7500'+ and tag.
4. Spot 200' Class "H" cement plug @ 4500'+.
5. Spot 200' Class "H" cement plug @ 2450'+ to give 100' above and below int. csg. shoe.
6. Spot 200' Class "H" cement plug @ 570'+ to give 100' above and below surface csg. shoe and tag up on plug.
7. Spot 50' Class "H" cement plug from 50' to surface.
8. Cut off wellhead, install dry hole marker, clean up and restore location as per BLM requirements.

Operations to commence immediately upon BLM approval. BLM field inspectors will be given adequate notice to witness all plugging operations.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

SPECIFIC INSTRUCTIONS
