1. Set 32# 8 5/8" Casing rather than 24#;
2. Use either Class B (Type II) AND/OR Class C (Type III) Cement for cementing the casing strings;
3. Since no gas problems surfaced in prior lease Yates wells (drilled with cable tools), nor are any gas problems anticipated in this well:
 - a. The BOP and 8 5/8" Casing will be tested simultaneously at 500#s prior drill out of cement with 7 7/8" bit;
 - b. A manually operated (Baker, 2 stage) pump for the hydraulic system will be utilized to close the BOP, without an additional accumulator;
 - c. Hi-pressure, reusable connections, steel lines, and hi pressure hoses will be used for the kill and relief lines, rather than welded or flanged fittings.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
