On September 26, 1991, 8-5/8" 24 PPF K55 STC casing was set at 2305' in an 11" hole. Casing was cemented with 200 sxs. (398 CF) Premium Plus Halliburton Light cement + 1/2#/sx. Flocele + 10#/sx. Gilsonite + 2% CaCl₂ + 1% Thixset Component A + .25% Thixset Component B followed by 470 sxs. (935 CF) Premium Plus Halliburton Light cement + 1/2#/sx. Flocele + 10#/sx. Gilsonite + 2% CaCl₂ tailed with 200 sxs. (264 CF) Premium cement + 2% CaCl₂ + 1/2#/sx. Flocele. No returns during job. WOC 8 hrs. Ran temperature survey - approximate top of cement at 700'. Grout 11" x 8-5/8" annulus back to surface using 3/4" tubing to circulate 210 sxs (336 CF) Premium cement + 3% CaCl₂. BOP's were nipped up on September 28, 1991 and tested to 3000 psi by Safety Test Inc. After picking up 7-7/8" BHA, casing was tested to 1500 psi for 30 minutes - test OK.
