7-4-92. Ran 34 joints 13-3/8" 54.5# casing set 1416'. Guide shoe set 1416', float collar set 1381'. Cmt'd w/850 sx PSL "C" w/10#/sx salt (yield 1.99, wt 12.4). Tail in w/200 sx "C", w/2% CaCl2 (yield 1.32, wt 14.8). PD 9:45 AM 7-4-92. Did not bump plug. Circulated 140 sacks. WOC. Drilled out 3:45 AM 7-5-92. WOC 18 hrs. NU and tested to 1000 psi for 30 minutes, OK. Reduced hole to 12 1/4" and resumed drilling. Notified BLM at 4:00 AM. BLM did not witness.
