Drill out of 13 3/8" casing with 12 1/4" bit at 11:45 PM 2-16-96. Drill 12 1/4" hole at 5:45 PM 2-17-96 at total depth of 1195'. Rig up and run 32 jts, 1200', 9 5/8", 40#, S-95, LT&C casing. Set casing at 1195'. Cement with 265 sx. PSL "C" + 1/4#/sx celloseal + 2% CaCl<sub>2</sub>, (yld-1.93 @ 12.5#), + 200 sx. Class "C" + 2% CaCl<sub>2</sub> (yld-1.32 @ 14.8). Did not circulate to surface. TOC at 79'. Ready mix to surface. BLM Carlsbad notified of running casing and cementing. WOC 18 hrs. Nipple up BOP. Test BOP to 1000 for 30 minutes. Plug down at 11:30 PM 2-17-96
