- PRESSURE CONTROL EQUIPMENT: Blowout prevention equipment, while drilling below 500', will be a 3000 psi working pressure BOP stack. The BOP sketch is shown as Exhibit 1.
- 6. <u>CIRCULATING MEDIUM</u>:
 - Surface to 500' : Fresh water spud mud Viscosity 30 to 33 as required for hole cleaning, 8.5-8.8#/gal. 500' to 1650' : Fresh water with lost circulation material as required, 28-30 viscosity, pH 9-10, weight 8.5-8.8#/gal 1650' to T.D. : Drill out with 10# brine system circulating reserve pit. Viscosity 32-40, pH 9-10 (control with lime).

Sufficient mud materials to maintain mud properties and meet minimum lost circulation and weight increase requirements will be kept at the well site at all times.

- 7. AUXILIARY WELL CONTROL AND MONITORING EQUIPMENT:
 - A. A kelly cock will be used.
 - B. A full-opening stabbing valve with proper drill pipe connections will be on the rig floor at all times.

- 9. ABNORMAL CONDITIONS, PRESSURES, TEMPERATURES, & POTENTIAL HAZARDS: No abnormal pressures or temperatures are anticipated. The estimated bottom hole temperature (BHT) at TD is 90 F and the estimated maximum bottom hole pressure (BHP) is about 1400 psi. No hydrogen sulphide (H2S) or other hazardous fluids are known to exist at this depth in this area. Possible lost circulation zones in the Artesia Group and the Capitan Reef.
- 10. <u>ANTICIPATED STARTING DATE AND DURATION OF OPERATIONS:</u> It is planned that operations will commence shortly after approval of this application, with drilling and completion operations lasting about 30 days. A decision as to design and installation of permanent facilities will be made after adequate testing of the well.

- 1. EXISTING ROADS:
 - A. Exhibit No. 2 is a portion of a road map showing the location of the proposed well as staked.
 - B. Exhibit No. 2A is a topo map showing existing pertinent roads in the vicinity of the proposed well site.
- 2. PLANNED ACCESS ROAD:
 - A. Length and Width: The existing lease road actually intersects the pad for this well. Traffic will likely be diverted around the east edge of the pad. If any new road is constructed, it will be about 12' wide.
 - B. Surfacing Material: Caliche, watered, compacted and graded.
 - C: Maximum Grade: Less than one per cent (1%).
 - D. Turnouts: None necessary.
 - E. Drainage Design: Any new road will be crowned with drainage to the side.
 - F. Culverts: None needed.
 - G. Cuts and Fills: Very little necessary.
 - H. Gates and Cattleguards: None necessary.
 - I. Existing access roads to the proposed wellsite will be used in their present state. Off-lease access approval, if necessary, will be executed under the Sheep Draw Federal No. 2 location.
- 3. LOCATION OF EXISTING WELLS:
 - A. Existing wells within a one-mile radius are shown on Exhibit No.
 3. There are no disposal, injection, or observation wells within the one-mile radius.
- 4. LOCATION OF EXISTING AND/OR PROPOSED FACILITIES:
 - A. Necessary production facilities for this proposed well will be located on the well pad. A layout of the production facilities is shown in Exhibit No. 5.
- 5. LOCATION AND TYPE OF WATER SUPPLY:
 - A. It is not planned that a water supply well will be drilled. Water necessary for drilling operations will be purchased and trucked from commercial water stations to the well site, or will be moved to the well site by temporary pipeline laid on the ground alongside existing and proposed roads.
- 6. SOURCE OF CONSTRUCTION MATERIALS:
 - A. Caliche needed for construction work will be taken, if present, from a pit opened on-site within the 400' X 450' work area. Otherwise, caliche will be taken from an existing BLM pit on Federal land in Sec. 5, T.23S., R.26E., Eddy County. Caliche will be trucked to well site over existing and proposed roads. Location of the nearest caliche pit is shown on Exhibit No. 2A.

7. METHODS OF HANDLING WASTE MATERIAL:

- A. Drill cuttings will be disposed of in the drilling pits.
- B. Drilling fluids will be allowed to evaporate in the drilling pits until the pits are dry.
- C. Water produced during tests will be disposed of in the drilling pits. After the well is permanently placed on production, produced water will be collected in fiberglass or steel tanks until hauled by transport to an approved disposal system.
- D. Oil produced during tests will be stored in test tanks until sold
- E. Trash, waste paper, garbage and junk will be stored in a covered, above-ground container. All waste material will be contained to prevent scattering by the wind. Location of the trash container is shown on Exhibit No. 4. No toxic waste or hazardous chemicals will be produced by this operation. The container will be emptied when full and taken to an authorized disposal facility.
- F. All trash and debris will be removed from the well site within 30 days after finishing drilling and/or completion operations. No adverse materials will be left on location. The unused portion of the well site will be leveled and restored to BLM specifications. Only that part of the pad required for production facilities will be kept in use. In the event of a dry hole, only a dry hole marker will remain.
- G. If required, a portable, chemical toilet will be provided on the location for human waste during the drilling and completion operations.
- 8. ANCILLARY FACILITIES:
 - A. No airstrip, campsite, or other facilities will be built as a result of the operations of this well.

9. WELL SITE LAYOUT:

- A. Exhibit No. 4 shows the relative location and dimensions of the well pad, mud pits, reserve pit, and the location and orientation of major drilling rig components. No permanent living facilities are planned, but a temporary foreman/toolpusher's trailer will be on location during the drilling and completion operations.
- B. Clearing and levelling of the well site will be required. Top soil, if available, will be stockpiled per BLM specifications as determined at the on-site inspection. No major cuts will be required.
- C. The pad and pit area are staked and flagged.

10. PLANS FOR RESTORATION OF THE SURFACE:

- A. After completion of drilling and/or completion operations, all equipment and other material not needed for operations will be removed from the well site. The location will also be levelled and cleaned of all trash and junk to leave the well site in an as aesthetically pleasing condition as possible. Any part of the pad not needed for production facilities will have the top soil replaced and reseeded.
- B. Unguarded pits containing fluids, if any, will be fenced.
- C. After abandonment, all equipment, trash, and junk will be removed and the well site will be cleaned. Any special rehabilitation requirements of the surface management agency will be complied with and accomplished as rapidly as possible.
- 11. OTHER INFORMATION:
 - A. Topography The land surface in the area is undulating and duny. In the immediate area of the well site, land slope is gentle down to the northeast, increasing upward rapidly in the vicinity of small mesas.
 - B. Soil Top soil at the well site is a loamy sand.
 - C. Flora and Fauna The vegetation cover is sparse and includes greasewood, beargrass, brambles, sand sage, yucca, weeds, and range grasses. Wildlife in the area is that typical of semi-arid desert land and includes coyotes, rabbits, rodents, reptiles, dove and quail.
 - D. Ponds and Streams No lakes, ponds, or streams are in the area.
 - E. Residences and other Structures There are no occupied dwellings or other structures, other than oil field related equipment, within a mile of the proposed well site.
 - F. Archaeological, Historical, and Cultural Sites None observed. However, an archaeological reconnaissance is accomplished and a report has been furnished.
 - G. Land Use Oil and gas production, grazing and wildlife habitat.
 - H. Surface Ownership Private.
