1. The oil, water, and gas from this well is moved through a flowline to the Sheep Draw Battery #2 located at NW/NE Sec. 33, T-22S, R-26E, Eddy Co., N.M.
2. The oil is sold to Amoco and trucked out from the Sheep Draw Battery #2.
3. The gas is transported through LDNG's gas lines to LDNG's Happy Valley Compressor Station. The gas is then sold to Highlands Gas Corp. through a meter located at NE/SW Sec. 15, T-23S, R-26E, Eddy Co., N.M.
4. The water is hauled out by Schurlock Permian to a State approved disposal well.
